This real life experience allowed those attending to get a real first hand sense of what happens. Paul Adler was able to take his listeners through his experience from the unexpected onset of the bends through the treatment in two different environments, one off of Florida and the second in Africa, to his present limitations in diving. For the twenty or so people at the clubhouse it was an informative and enjoyable evening.
