RECENT EVENTS

AUGUST 3rd — ANNUAL OUTING

While the highlights of our *Annual Summer Outing* on August 3rd were summarized in our September *Soundings*, the *Financial Report* was not finalized in time for inclusion in the article.

Treasurer Czerepica has since reported “fees from 92 adults had been collected, and 3 children (ranging in ages 5 and younger) were admitted free-of-charge”.

The *Annual Summer Outing* was never intended to be a fundraiser, like our *Annual Flea Market*. The purpose has always been to have one day each year as a social event where members could invite their families and friends. The *Club* also extends an invitation to others within the diving community to join us for a fun-filled beach day at a reasonable price.

Members involved with planning, preparation and execution of this event over the years, have spent Club money conscientiously to obtain the necessary permits, pay fees for trash removal, purchase paper goods, food, beverages, prizes, etc.

In 2007, a total of 95 adults attended the *Outing*. Ticket prices were \$10.00 each, and children ages 5 and younger were admitted free. The *Treasurer's Report* detailing the expenses from the *Outing* last year showed the Club lost a total of \$400.00.

The *Board's* initial response to the loss, was to increase the ticket prices for adults. Increasing ticket prices for adults in 2008 to \$12.00 would help relieve the short-fall to the club, while keeping the event affordable.

Treasurer Czerepica reported “the paper goods, condiments and other related items discovered during the *Annual Clubhouse Cleanup* in May used at the *Outing*, resulted in a significant savings in expenses”.

Net-net for the **2008 Annual Summer Outing ... This is the first time in the Club's history, we realized a \$229.55 profit !!!**

SEPTEMBER 13th — WATERFIRE

On Saturday, September 13th *President Blackadar* coordinated a *Club Activity* at *WaterFire* in downtown Providence, Rhode Island. *Club Members*, their families and friends walked the 2-3 mile area along the river in downtown Providence.

It was a crisp, clear autumn evening, delightful music filled the air, and floating candles illuminated the river to guide gondolas gracefully through the peaceful water. The sound of a live jazz band enticed our guests into a building with a large dance floor.

Independent non-profit art groups present *WaterFire* free-of-charge however, donations are graciously accepted. A beautiful evening enjoyed by everyone who attended, and agreed the *Neptunes* should plan this event again next year ... so YOU can join in!

OCTOBER 4th — ANNUAL FLEA MARKET & CRAFT FAIR

Although the *Financial Report* of the *Annual Flea Market and Craft Fair* on October 4th has not yet been finalized, *Chairperson Angelo Correnti expects over \$150 increase in profit from last year from the sale of table space, admission, food and beverages sold, etc., plus the reduction in expenses !!!*

Angelo said, “it was a pretty good time”. The night before, there was a lot of help from **Joe McAndrew, Tom Curran** and **Bill Burchill** setting-up our area within the parking lot of Building 19-1/3rd.

At approximately 5:30a on Saturday, vendors began arriving to set up their tables. “Arranging vendors, tables and cars in the parking lot was just like putting together a big jigsaw puzzle”, said Angelo. *Flea Markets* this year have experienced less participation from vendors, and have had a decline in attendance and sales. Our vendors were pleased with the cost of table space, the price of admission, and the amount of people who attended and spent money at their table.

“A lot of people helped with the entire event ... collecting admission fees, selling food and beverages at our Food Tent, and selling goods at our table”. This year, we had a “higher quality” of items to sell; **Bill Burchill** brought (*and wore*) a lot of saleable items. Donations of items from our members and their families also contributed to the profits received at our tables.

During September's 3rd *Tuesday Night Meeting*, Members **Jeannine Faban, Ted Hotz, Deb Osborn,** and **Karen Correnti** pre-priced items for sale. There had been discussion to be prudent to price items to make a profit, yet price items to sell. On the day of the *Flea Market*, Shoppers willingly paid the price displayed on the item's sticker without haggling or negotiating.

At the end of the day, many helping hands made break-down and clean-up quick and easy.

Over the years, to celebrate the conclusion of this successful annual event, it is tradition for our group to go out to dinner. This year, thirteen hungry *Neptunes* chose a local Chinese restaurant. There was a variety of food to share which was delicious, plentiful and “priced to sell”.
