Last Month - June 1988

The Beginning of Summer Party took place on June 5th at Georges Island. Approximately 90 members and guests braved the dreary early morning boat ride out to the island. Once ashore, the skies cleared, and the serious partying began! There were refreshments, volleyball games, a softball game, and tours of Fort Warren. A good time was had by all. Special thanks go to the boat owners who helped shuttle the food and supplies out to the island.

The Annual Bay State Council Treasure Hunt took place on June 12th at Stage Fort Park in Gloucester. Conditions were ideal for the competition, the weather was warm, the sky was clear, and the sea was flat calm. The underwater visibility, however, was less than ideal, giving the Neptunes a measurable edge. A total of 71 divers registered for the scuba event and 4 clubs registered for the snorkel event.

As in previous years, the scuba competition was the first event of the day. This event was open to all certified divers, both experienced and novice alike. The area was seeded with over 400 numbered scallop shells, and the divers were instructed to recover a maximum of 8 shells each. Later, numbers were drawn from a hat and prizes were awarded to the divers holding the corresponding numbered shells. As expected, the Neptunes did extremely well, winning a small fortune in useful dive gear.

Following the scuba competition, the Moray Wheels, Project Deep, Lowell Underwater, and the South Shore Neptunes snorkel teams assembled on the beach for the main event—the snorkel competition. The area was seeded with 1000 marbles and the snorkel teams were instructed to collect as many marbles as possible in one hour. At the end of the hour, the South Shore Neptunes had won the first place trophy, followed by Project Deep in second place and the Moray Wheels in third place.

Last Month - June 1988

This is the third year in a row that the South Shore Neptune's snorkel team has won the first place trophy. However, the Project Deep team did well this year and has threatened to blow us out of the water next year. We may have to enter the *A Team* next year, just to take the wind our of their sails!

The Dive Team ran a <u>Used Bicycle Sale</u> on the 19th at the Quincy Civil Defense Building. Over 70 bikes were sold and \$722 was raised. Part of this money will be used to buy new parts for the Dive Team boat and the rest will go into the new Dive Team truck fund. Special thanks go to everyone who helped make the sale a success!

The June 26th Point Dive was originally scheduled to be a boat dive at Boston Light. However, due to threatening weather and sea conditions, the site was changed to a safer location off Great Brewster Island. Underwater visibility was a poor 5 feet, and the bottom scenery was much like Pleasure Bay—MUD. Despite these conditions, approximately 53 lobsters were taken, 22 of which were caught by Dick "Bloodhound" Gullicksen. After the dive, the sky cleared and everyone motored over to Georges Island for lunch and a game of volleyball. All in all, everyone had a good time. Special thanks go to those members who provided boats for the day—Angelo Correnti, Dick Gullicksen, Chris Tabor, and Ted Hotz.
